PROJECT SCOPE

This new, 3-year program is funded by the Natural Resources Conservation Service under a Grazing Lands Conservation Initiative (GLCI) grant, and implemented by the Conservation Services Division of the Colorado Department



of Agriculture (CDA). The purpose of the program is to build local weed programs to detect and eradicate six currently uncommon noxious weeds before they gain a significant

foothold in Colorado's Eastern High Plains. By targeting these emerging invasives in the plains, small, outlying patches can be eradicated before they become huge, costly problems for local communities. The target species are diffuse knapweed (Centaurea diffusa), Russian knapweed (Acroptilon repens), spotted knapweed (Centaurea maculosa), Dalmatian toadflax (Linaria dalmatica) and leafy spurge (Euphorbia esula). Saltcedar or tamarisk (Tamarix spp.) will be targeted only in the Republican River Watershed due to funding limitations.

Partnerships

Communities are strongly encouraged to create partnerships among conservation districts,



weed programs, counties, watershed associations, NRCS field offices, CSU extension, private landowners and others -- in order to

for 2008, 2009 and 2010. Awards will be made to community partnerships with weed management plans based upon scouting and mapping species' abundance and distribution in their area. The grant application period begins January 14, 2008 and ends March 14, 2008.

ASSISTANCE

CDA will assist communities and landowners form partnerships, provide educational presentations and literature, and assist with current methods in the field to help scout, map, and treat these species. and Integrated Weed Management. Through early detection and management of these six invasive species, we hope to preserve the ecological and economic values
