## Recommendations for Safe School Plans

## **Campus Access and Control:**

- Control Campus Access
- Define campus perimeters with appropriate landscaping and fencing
- Remove posters and student decorations from all window glass
- Establish uniform visitor screening procedures
- Post-appropriate directional signs on the campus
- · Require picture identification cards for each student and staff member
- Carefully manage and monitor hall passes
- Clearly separate and segregate mixed vehicular and pedestrian functions

### **Administrative Leadership:**

- Mandate crime reporting and tracking
- Place school safety on the educational agenda
- Include school safety in the mission statement
- Develop a comprehensive, system-wide safe school plan
- Disseminate a summary of laws pertaining to school disorder
- Establish a state of the art "Emergency Operation Communications Center"
- Develop a clear job description of duties and responsibilities for school peace officers
- Establish a crisis response plan
- Identify specifically assigned roles and responsibilities concerning security
- Work with administration to expand the network of alternative placement for troubled youth
- Establish a restitution and community service program at district schools
- Recognize the politics of safe schools
- Establish good management practices
- Conduct an annual review
- Promote crime prevention through environmental design
- Establish two-way communication between the front office and each classroom
- Identify and track repeat offenders
- Provide close supervision, remedial training and restitution for serious habitual offenders
- Carefully screen and select new employees
- Conduct periodic joint meetings of all school staff and faculty
- Utilize existing technologies that promote crime prevention

#### **School Climate:**

- Make the campus safe and welcoming, beginning early in the morning
- Develop a nuisance abatement plan
- Develop a graffiti abatement and community clean-up program
- Create a climate of ownership and school pride
- Establish a Parent Center on each campus
- Enhance multi-cultural understanding
- Establish a vibrant system of extracurricular programs

#### **Student Behavior and Management:**

- Review the student handbook
- Articulate a clearly defined locker policy
- Develop and enforce a school dress code
- Review discipline and weapon possession policies
- Place students and parents on notice
- Provide adequate adult supervision
- Limit opportunities for the transport and storing of contraband
- Automobile and parking polices should state that campus parking is a privilege, not a right
- Add "hard looks" and "stare downs" as actionable offenses to the student code of conduct
- Train students to take responsibility for their own safety Conduct emergency drills

## **Staff Training:**

- Conduct annual school safety training programs
- Establish an active school peace officer training program
- Provide teacher training in behavior management
- Establish professional development programs for campus supervisors and student personnel workers
- Establish a physical restraint policy

#### **Student Involvement:**

- Create an active student component
- Implement a peer counseling and peer mediation program at every school site
- Incorporate life skills curricula
- Create a student advisory council
- Develop a student crime prevention program
- Consider teen court as an option

## **Building Community Partnerships:**

- Identify community resources
- Enhance interagency cooperation by creating a partnership among youth serving professionals
- Seek intensive community support and involvement in making the journey to and from school safe
- Establish a close law enforcement partnership
- Closely supervise troublemakers across agencies
- Capitalize on the school's ability as an organizational vehicle to provide comprehensive student services
- Consistently enforce the information sharing agreements
- Consider placing a probation officer on campus for students on probation
