Cash Fund Transfer from Colorado Travel and Tourism Promotion Fund to the General Fund

Proposal:

This proposal seeks a legislative change to transfer \$2.5 million of fund balance in the Travel and Tourism Promotion Fund to the General Fund for FY 2010-11. This sum equates to the amount of existing fund balance for which the Office of Economic Development and International Trade does not have current or prior roll-forward spending authority.

Summary of Request:

- Created in 2001, the Colorado Tourism Office replaced two previous promotion entities: the Colorado Tourism Board and the Colorado Travel and Tourism Authority. Governed by a Board of Directors (consisting of four legislators and eleven Governor-appointed members), with administrative oversight provided by the Governor's Office of Economic Development and International Trade, this office seeks to promote Colorado as a tourism and travel destination.
- Under current law, the Colorado Tourism Office uses the Colorado Travel and Tourism Promotion Fund for travel and tourism development activities benefiting the state. The Colorado Tourism Office is also authorized to distribute cash funds from the Colorado Travel and Tourism Promotion Fund to various regional and statewide associations, organizations, and other non-profit entities for the purpose of enhancing marketing efforts. Funds are distributed in the form of matching grants and are distributed based on an annual competitive process.
- Beginning in FY 2006-07, Long Bill spending authority for the Office of Economic Development was revised for programs supported by the Colorado Travel and Tourism Promotion Fund, allowing for roll-forward authority for any unexpended appropriation at fiscal year-end. Prior to that period, the Department's annual expenditures were limited by the annual spending authority for the fiscal year, and any unexpended funds at each fiscal year-end remained in the fund.
- This proposal seeks to transfer \$2.5 million in available fund balance to the General Fund. Aggregated current year and roll-forward spending authority will not be affected as a result of the requested \$2.5 million transfer to the General Fund.
