HISTORY

THE Colorado Humane Society was incorporated August 6, 1881. The incorporators were Wolfe Londoner, J. H. Estabrook, Oliver S. Buell, John R. Hanna, R. S. Wilson, Hugo Preyer, Frank Hunter, Dr. N. G. Burnham. Wolfe Londoner was the first president. The presidents since then, in their order, have been Charles H. Smith, Walter S. Cheesman, Thomas S. Walsh, and E. A. Colburn, the incumbent.

The objects of the Society, as set forth in the articles of incorporation were: "1st, Prevention of cruelty to animals by all proper means and the prevention of *all* cruelty by humane education and prosecution if necessary. 2nd, Prevention of cruelty to children and neglect of children and protection of the wives of intemperate husbands."

All the incorporators were among the best known citizens of that day. All of them have long since gone on. After the first few months the Society became inactive and for several years did little except to hold annual elections.

In the fall of 1885, a call for a public meeting to reorganize the Society was issued by the then secretary, Charles W. McCord, to meet in his office in the Welch Block, which stood where the Foster Building now stands. Fifteen persons came and reorganization was effected with a board of fifteen directors composed of all those present. Charles H. Smith was elected president and C. W. McCord re-elected secretary. President Smith at once raised \$1,000 among his friends and acquaintances and General David I. Cook was employed as agent. Secretary McCord shortly resigned on account of ill health and E. K. Whitehead was elected the first active secretary. As soon as due attention was paid to reports and complaints, the work of the Society grew so fast the secretary was obliged to resign, with the recommendation that a paid secretary be employed. Gaylord H. Thomson was elected secretary, the former secretary becoming treasurer. Secretary Thomson held the office till 1896. During that time, and chiefly through his efforts, much of the fundamental legislation for the protection of children and dumb animals was enacted, enforcement of the law was vigorous, and the Society became a real force. In 1896, Secretary Thomson resigned and the present secretary was elected again as a temporary measure, which for various reasons has stood for nearly thirty years.

Up to this time the Society's work had been confined chiefly to Denver for lack of funds to extend it outside in the state. But there seemed to be no good reason why a few interested persons should try to maintain a public service of such extent and importance as the protection of children and dumb animals, made necessary by reason of their helplessness. Accordingly, in 1897, again in 1899, and lastly in 1901, the Society caused a bill to be introduced in the Legislature to create a State Board of Child and Animal Protection, with an office in the State House, an appropriation from the State and the prestige and power of being a part of the regular government of the State, representing all the people of the State, instead of a Society representing its members only. In 1901, the bill became a law and the Colorado Humane Society became also the State Bureau of Child and Animal Protection, the first time in history that the protection of abused and neglected children and dumb animals became a function of regular government as distinguished from a society or other private organization. An appropriation of \$3,000 per year was made and the Bureau undertook at once to extend its activities throughout the State. Since then the Bureau has gone on extending its work, its power and influence, and from time to time increasing its appropriation, now \$10,875 per year, which provides for a secretary, three state officers and a clerk and stenographer, with incidental expenses for the office and traveling expenses for the three state officers and, of course, an office in the State House.

The advantages in prestige, power and dignity of being a state board instead of a society are so many and so great they cannot be explained here, as long as the Bureau is kept free from political influences, and in the hands of persons who will not sacrifice its objects to anything else. If, however, it were subject to political control, its work would have no continuity of plan or purpose, its directors and employees would be chosen for political reasons instead of sincere and active interest and ability and the enforcement of law for helpless, abused and neglected children and dumb animals would, when occasion required, be sacrificed for political expediency.

Volunteer Officers

Volunteer officers are unpaid. They are men and women who want children and dumb animals protected and who are willing to take and exercise the authority the Bureau is able to give them without compensation except the satisfaction they get in securing such protection. They have the same authority the regular state officers have, which is elsewhere explained. They are likely to give offense in the discharge of their duty to many persons whose good will in a social or business way they would like to keep, but they are willing to run that risk for the sake of the good they can do. The value of the service they render to the State cannot be computed. For example, if each one of the fifteen hundred volunteer officers were to devote an hour a month on the average to this work-and most of them give much more than that, some of them days per month instead of hours-it would amount to twelve hours per year each, a day and a half each, or two thousand two hundred and fifty days a year in the aggregate. At three hundred working days a year that would equal the services of seven and a half paid officers, each giving all his time to the work. As a matter of fact, such an estimate gives only a small glimpse at the real value of their services. In almost any smaller community the mere presence of a Humane officer there influences the general attitude toward child and animal protection and respect for law generally. The sentiment of the public gradually rises till, in a short time, little occurs calling for his interference. The indirect effect of this influence on law and order in all ways can hardly be overestimated. Colorado has 104,000 square miles of plains and mountains-almost twice the size of all New England-with a population of a million. About how near could three paid state officers come to looking after all the abused and neglected children and dumb animals if it were not for the invaluable aid of these volunteers?

The following list of Volunteer Officers is the first complete one to be published. It covers more than thirty-five years, during which such appointments have been made. For many years badges were not numbered, the first one to be numbered being one hundred, there being at that time about that number outstanding. The difference between the badge numbers now reached—nearly 3,400—and the present number of officers—between 1,600 and 1,700—is accounted for by the original start at 100 referred to, by badges lost, stolen and destroyed and by deaths and removals. The badge numbers increase about twice as fast as the number of officers.

No record of occupation of officers was kept for many years and also, naturally, the occupation of many has changed since appointment, while in a new state like this, residence changes so frequently that it is very hard to keep track of it. The list gives, as nearly as we are able, the name, address, occupation and date of appointment of every Volunteer Officer who could be located within the past twelve months in the State. The Inquiry List of Volunteer Officers following this one contains the names, no doubt of many Volunteer Officers who are still here and still active but whom we have not been able to locate. Any information concerning them will be appreciated. It is partly in hope of receiving it that the Inquiry List is here published. All Volunteer Officers are here earnestly urged to keep in touch with the office from time to time and to notify it without fail of any change in address so that we may keep in closer communication with the Volunteer Officers, on whose work so much of the efficiency of the Bureau depends.

Without doubt many errors will be found in the list. We shall be grateful for corrections. It is the best we are able to do after the lapse of time and under present circumstances. In the main the list will be found correct.

The Laws to be Enforced

It is the duty of the State Bureau of Child and Animal Protection by the terms of the law creating it to "secure the enforcement of the laws for the protection of children and dumb animals." This means ALL such laws, and fixes no limit on what the Bureau may do or the means it may employ.

The laws of Colorado prohibit every imaginable kind of unnecessary injury to either children or dumb animals—so that it becomes the duty of the Bureau to protect them in any way they may need and to use any means in so doing that may be necessary.

For our own convenience we divide the children who may need the Bureau into five classes:

(1) Abused children, who are the victims of active injury, such, for instance, as beating, threatening, starving, overworking, etc.

(2) Neglected children, who are the victims of passive injury, such, for instance, as remediable bad health, lack of schooling, uncleanliness, lack of discipline and training, bad example, bad company, etc.

(3) Dependent children, who have nobody against whom their support and care can be legally enforced, either for . lack of law or because it cannot be for some reason enforced.

(4) Delinquent children, who are not properly controlled or who cannot be so controlled by parents or other natural or artificial guardians so that they become law-breakers.

(5) Defective children, who are physically, mentally or morally defective to such a degree and under such circumstances that they have to be dealt with by authority other than their parents or guardians.

To deal with these various classes there are many laws and state institutions. Some cases can be handled by the application of any one of several or sometimes more than one. Following are some of these laws and institutions to which some of them relate, not always in the order of their importance: (1) The general law against wrongs to children committed by those in whose charge the children are. This forbids any one or ones of a category of wrongs, and at the end has the blanket provision "or in any other manner injure such child." This covers any unnecessary injury, and, enforced by an intelligent and conscientious court, would render any other legislation of a punitive character such as the numerous statutes passed since this one was (1891—thirtyfour years ago, and passed at our instigation and request) unnecessary. Enforced by fine and imprisonment. Sec. 6910 Comp. Laws, 1921.

(2) Compulsory school law. (Enforcement of this law brought about by us, in recognition of which fact the then superintendent of Denver schools, Dr. Aaron M. Gove, offered us the privilege of naming the first school attendance officer in the State, twenty and odd years ago.) Under this is the law providing for appointing the secretary of the school board the attendance officer in districts of the third class, drafted by us and passed at our request. Sec. 8468, C. H. 1921.

In addition to the foregoing we take action under any law whereby the welfare of children may be promoted, whether it refers directly to children or not, such, for instance, as commitments to the State Hospital for the Insane, to the Penitentiary or State Reformatory, or to the city or county jails, appointment of guardians for either the person or estate, commitment to hospitals, etc., and take action for the reform or improvement in management of any institution, state or otherwise, caring for children.

Among the laws for the protection of dumb animals which we enforce are:

Extracts from the Law

The laws relating to the protection of children and dumb animals would make a large book if printed in full. In the references to them given here only one section is given, though there are always many others relating to procedure and other collateral matters which were parts or sections of the original statute when it was passed, and which can usually be found in close connection with the section given.

However, it may be to the convenience of our officers and others if we give here a few extracts covering points which most frequently arise.

The powers of our officers in dealing with dumb animals are set forth in the Instructions and Suggestions to Officers found on pages of this book, and the numbers of the principal sections under which they act are given under the complete list of laws we enforce to be found on pages 78 to 83, inclusive, in this book. It may be added that in the case of animals injured on railroad rights-of-way, it is the duty of both the railroad and of the owner to provide relief at once for the animals, and in so doing neither one admits or relinquishes any rights he may have in a settlement for damages.

(1) The law establishing the Bureau of Child and Animal Protection provides, among other things:

"It shall be the duty of the said bureau to secure the enforcement of the laws to prevent wrongs to children and dumb animals; . . ." C. L. 1921, Section 685.

At the time of its enactment this statute was purposely so worded in order to open the door for the exercise of whatever authority might be necessary in the great variety of cases sure to arise. If the law imposes a duty it must by necessary implication carry with it whatever authority is necessary in order to discharge that duty. Otherwise the law would stultify itself. This is the comprehensive source of the authority the officers of this bureau exercise in cases where no statute specifically empowers or directs them.

(2) The law relating to dependent and neglected children provides: "When any such child within the provisions of this act is in immediate or apparent danger of . . . serious injury . . . any officer of the State Bureau of Child and Animal Protection . . . may take immediate custody of such child without any process whatever." C. L. 1921, Section 604.

(3) The laws relating to the offender provide:

a. "It shall be unlawful for any person having the care and custody of any child wilfully to cause or permit the life of such child to be endangered or the health of such child to be injured . . . or in any other manner injure such child." C. L. 1921, Section 6910.

b. ". . . the words 'dependent' child or 'neglected' child shall mean any child under sixteen years of age . . . who has not proper parental care . . . or whose home by reason of neglect on the part of its parents . . . is an unfit place for such child." C. L. 1921, Section 602.

c. "In all cases where a child shall be a . . . neglected child as defined by the statutes of this state, the parent or parents . . . shall be guilty of a misdemeanor . . ." C. L. 1921, Section 615.

d. Any man who shall wilfully neglect, fail or refuse to provide reasonable support and maintenance . . . for his child or children under sixteen years of age or who wilfully fails, refuses or neglects to provide proper care, food and clothing in case of sickness for his . . . child or children . . . shall be deemed guilty of a felony . . ." C. L. 1921, Section 5566.

e. "Any person . . . who, having the custody, control or supervision of such child, shall wilfully neglect to do that which will directly tend to prevent such state of . . . neglect . . . or to remove the conditions that render such child . . . a neglected . . . child shall be proceeded against as provided herein." C. L. 1921, Section 644.

The two following extracts from the law apply to the liability of elected and appointed officers who do not do their duty. They are given here because they are not generally known. The second one applies to our officers as much as to any others but it should be said that our officers seldom need to have it applied to them.

(a) "Every clerk, sheriff, coroner, constable, county commissioner, justice of the peace, recorder, county surveyor, or attorney general or prosecuting attorney . . . who shall be guilty of any palpable omission of duty or who shall be wilfully or corruptly be guilty of . . malfeasance or partiality in the discharge of his official duties shall upon conviction thereof be fined . . ." C. L. 1921, Section 6819.

(b) "Every person elected or appointed to any office, or to any and every position of trust and employment under the laws of this state, or under any ordinance of any municipality in this state, who shall violate his oath of office or fail and neglect to perform the duties of his office as prescribed by law or ordinance shall, upon conviction thereof upon indictment or information be fined . . ." C. L. 1921, Section 6820.

(c) "Any person who shall encourage, cause or contribute to the . . . neglect of a child . . . or shall do any act or acts to directly produce, promote or contribute to the conditions which render such a child a . . . neglected . . . child . . . shall be proceeded against as provided herein" C. L. 1921, Section 644.

School Laws

The school laws are so numerous and so voluminous that they alone make a book of considerable size. The two provisions with which our officers need most often to concern themselves are, briefly stated:

Every child between the ages of eight and sixteen is required to be in school every school day in the year. Up to fourteen a few exceptions are made, such as illness, schooling given in some other way, and one or two others, but not need of the child's labor, as some parents would like to claim. Between fourteen and sixteen the school board is given some discretion in issuing permits to stay out when in their opinion it should be done, but no such discretion is given with children under fourteen. Parents can be held to strict compliance with the law.

In matters relating to school houses, teachers and the general business of schools the school board of the district is supreme, generally speaking, except when they ignore some duty imposed by law. The law does not impose many duties upon them, but leaves much of the school business to their discretion.

Instructions and Suggestions to Officers

TO OFFICERS

When a case of apparent ill-treatment of either children or animals comes to your notice, either because you see it yourself or because somebody tells you of it, stop and weigh in your mind:

- (1) Whether it really is ill-treatment or not; does it cause unnecessary suffering or injury?
- (2) What the best action for you to take is:

(a) To relieve the child or animal;

(b) To punish the wrong-doer if he ought to be punished.

Ask yourself such questions as these: What are the exact facts? What ought I to do first? Who is to blame? What orders, if any, ought I to give? What is the best thing for me to say? The best thing for me to do?

In most cases no prosecution is needed or best. But sometimes it would be wrong not to prosecute. Ask yourself whether you ought to prosecute? What shall I prosecute for? Who would be my witnesses? What would they testify to? Who would be the offender's witnesses, and what will they testify to?

As a general thing the first thing to be done is to stop the abuse then going on, if possible, right away, and see about the punishment later.

Don't rely too much on the statements or the views of others. Few persons are accurate even when they are truthful. The responsibility is on you anyway. Use your own judgment and make sure you are right.

If you are uncertain whether you should prosecute or bring any kind of case in court, consult the District Attorney or the office in the State House. Unless you have had experience, they are better judges of whether the case is a good one and what effect the evidence will have than you can be. Moreover, the right to decide whether the case should be prosecuted at all or not rests with the District Attorney. In any event, it is best to have him on your side and in sympathy with you. If, however, it is desirable to bring an immediate prosecution, go to the justice of the peace and under his direction make out your complaint and furnish him a list of your witnesses. Be sure to talk with the witnesses first and find out just what each one knows of his own information, not what he knows by hearsay, for he will not be permitted to testify to that. Get the facts clearly in their minds by talking with them. The District Attorney will prosecute your case for you if you have his approval from the start.

In any case of uncertainty, don't hesitate to write the office in the State House, nor to consult the District Attorney.

AUTHORITY OF OFFICERS

Officers of the State Bureau of Child and Animal Protection are officers of the State. Their authority is, accordingly, good anywhere in the State. Paid officers and volunteer officers have the same authority under the law.

They may do whatever is necessary in order to properly enforce the laws for the protection of children and animals. Due regard must be paid to the word "necessary" and "properly" in the preceding and following sentences.

They have a right, when necessary:

1. To go armed.

2. To arrest persons found abusing or neglecting children or animals, using force if need be.

3. To arrest persons resisting or interfering with them while enforcing the law, using whatever force is needed.

4. To take possession, by force if need be, of either children or animals, if necessary to protect them from abuse or neglect.

5. To hold possession of animals so taken against the owner until the necessary expense of caring for them is paid.

6. To condemn and destroy animals when necessary for their protection according to law, being careful to observe the terms of the law.

7. To call upon any peace officer to take charge of an animal abused or neglected, or to arrest any person committing such abuse or neglect.

Such are the general powers of our officers. As will be seen, they are sufficient to deal promptly and effectively with any case of child or animal abuse or neglect. They are largely discretionary, also, and must be exercised with careful regard to the necessities of each case, so as to do the most possible good with the least possible harm.

Our officers have no authority, except in dealing with children and animals, beyond that of any citizen. They are not peace officers.

Their powers as officers cannot be used for personal ends either. Our officers have no right to go armed except when they are on duty as such officers and for the purposes of such officers. An officer has no right as an officer, for instance, to go armed because he expects trouble over something not connected with the protection of children or animals. If he goes armed for such a purpose, he cannot claim justification as an officer of the Bureau.

Some of the powers specified are given expressly by law, and some, like that of going armed and of making arrests, by implication. The law makes it the duty of our officers to enforce the laws for the protection of children and animals. It cannot, then, withhold any power necessary to discharge that duty. It would be a manifest absurdity to make it one's duty to do a certain thing and at the same time withhold the authority or means to do it.

When the law relating to arrest and to the carrying of arms was passed there was no such thing as the State Bureau of Child and Animal Protection, with its officers, upon whom the law lays certain duties and obligations. It has come into existence and its services to the people have grown up since, and are, therefore, necessarily not mentioned.

It should be borne in mind by officers that the way to exercise authority so as to provoke as little opposition as possible, and get the best results in all ways, is to do it firmly but quietly. Don't be arbitrary, overbearing, or unnecessarily rough in manner or language. It is human nature to resent that sort of conduct in an officer, when, very likely, his actual exercise of authority itself would not be resented.

On the other hand, an officer's conduct should not be hesitating, timid, or apologetic. He should not forget his high place as an officer and representative of the people of the State, doing a duty laid upon him by law, and protecting helpless children and animals. He should be firm, confident, and certain of himself.

He should treat the man he is questioning or correcting in such a way as to give no unnecessary offense, but yet as an officer doing his duty. It is not a personal matter with him, but an official one. He should make sure he is right and then make his point stick.

SUGGESTIONS TO OFFICERS IN DEALING WITH CHILDREN

When possible, parents should be made to take care of their children and bring them up properly, but the child's interests should not be sacrificed in trying to do so.

Parents should be encouraged to keep their children not to give them up.

Every case should be carefully thought over and studied, with a view to doing the best possible thing for the children. A little thought and thorough investigation will generally prevent mistakes.

If children have to be taken away from parents, or if they have no relatives who can properly care for them, it is generally better to have them sent to the State Home to stay temporarily until homes can be found for them. That is what the State Home is for. It does nothing else. It has ample means and full authority, and no anxiety need be felt when children are once safely committed there.

With wayward or misbehaving children, kindness must be used about evenly tempered with firmness. They have no respect for anyone too weak to control them, and most of them will take advantage of kindness unless backed up by good, robust discipline.

Child labor, in the sense of labor injurious to the child, is a bad and unlawful thing. Almost equally bad is child idleness. It is a good thing for children to work, but not too much. It is a good thing for them to play, but not too much.

In dealing with them, remember that they are very much like us; or, rather, we are very much like them. What would work well with us generally works well with them. What offends and displeases us generally does so with them. Children love a square deal, a sympathetic and understanding heart, and an eye indulgent to trifles. But they also respect real manliness and real womanliness, and are seldom deceived. Be just as sincere, straightforward, kind, and businesslike as you know how, and you will have little trouble. The same thing is true of our relations to grown-up people.

INSTRUCTIONS TO AGENTS IN DEALING WITH NEGLECTED STOCK

When stock is found neglected and suffering, if practicable, notify the owner and give him a chance to care for it himself before you do. You must use judgment about this. If the owner is too far away, or the animals are suffering much, don't wait for the owner.

In all cases get word to the owner as quickly as possible. In all cases try to keep down the expense, the same as you would if the stock were your own; but while doing so, don't let the animals suffer.

The utmost good faith and sincerity should characterize every action of an agent. Nothing will so quickly destroy his influence for good and confidence in him as the belief that he is dishonest or actuated by mercenary motives.

While he has a right under the circumstances, as set forth in the law, to make a reasonable charge for his services in caring for neglected or abused animals, he should never take advantage of his authority to overcharge, and should be guided by what he would have charged if the owner had come to him to make a bargain before the services were rendered.

In other words, an agent should never let himself use his authority to make money. That is not what it was given him for. Even if, as often happens, the owner of neglected stock is entitled to little consideration on account of his inhumanity, the way to punish him is not by overcharging.

If an agent is fair, impartial, and sincere, he can generally make a friend even of the man against whom he is enforcing the law. He cannot hope to do that if he is not absolutely honest, but, on the contrary, will make enemies for himself and the cause he represents.

Nothing here said is to be taken to mean that an agent must render his services for nothing, or for less than they are worth, when he is entitled by law to make a charge. His enforcement of the law is a matter of business, and the exercise of his authority as an officer of the State. Moreover, the owner of the stock cared for profits by his action and should pay for it a reasonable price.

There is meant only that the agent should not take advantage, but should be perfectly fair, upright, and aboveboard in his actions, and should then compel the respect to his orders which is due to him as exercising the authority of the people of the State.

The law does not require publication of notice in a newspaper, but when it appears at all likely that animals taken charge of and about to be sold will bring enough to pay the additional cost of advertising in the official stock paper, that should be done, just as is done in the case of estrays.

Whenever any stock is taken up because it needs care, notify the board at the State House, giving particulars of taking, descriptions, brands, etc. Whenever a sale occurs, furnish full information to this office at once.

Take up no range stock unless actually suffering, except when found where they can reach no feed.

Keep full and complete records of dates, names, brands, amounts, etc. Give and take a receipt, and make it a careful and correct matter of business.

If an owner comes to redeem stock, do not let him redeem some and leave the rest.

If there is some poor and some good stock to be sold, bunch some of both kinds in lots and sell the lot. Otherwise you will have the worthless stock left on your hands.

Whenever you post sale notices, send one copy to this office.

When stock is redeemed, collect all items of expense for each head for the number of days held, including gathering, advertising, etc.

Employ only honest and trustworthy help.

Keep strictly to the law. Do whatever the law says shall be done. Do it in good faith, and take no advantage of anyone. Treat all alike and all fairly.

SUGGESTIONS TO AGENTS

The following suggestions, founded on the experience of many years, may be useful to inexperienced agents:

Remember that you are not a private citizen, but an officer of the law, representing not merely the State Board of Child and Animal Protection, but the people of the State of Colorado. Do not allow abusive language of yourself; it constitutes disturbance and can be punished as such. Do not, of course, permit any effective resistance to your actions or orders. Maintain the dignity of your office. Whenever a case comes under your own observation, or is reported to you, avoid excitement. You don't have to be excited; you have the law and the people of the State back of you. If anybody is to be excited, let it be the other man. If you get excited, you will be pretty sure to do or say something you will regret. Quietly and carefully, but firmly, investigate until you have satisfied yourself as to the condition of things and what ought to be done. Then do it. If you go at it in this way, you will not be likely to make any mistakes, and you will not irritate people unnecessarily.

Very often people are cruel without really meaning to be, because they do not know any better, or have never thought much about the rights of children or animals. If you go at people in a friendly but firm way, very often they will acknowledge their fault and meet you half way. Be patient with ignorance and mistakes, and wait for anger to cool. Persuade people to do what is right if you can; but if you cannot, then compel them. If a man is ugly after such treatment, or has done an intentionally cruel thing, make him fear you; but do it in a quiet way, without apparent feeling or excitement. Make the people you go after understand that you have no ill-feeling toward them personally, but that as an officer you must do your duty. Appeal to their reason, their sense of what is right and just. Don't lecture, scold, or abuse people. They don't care what you think, but they care a great deal what the law says. Warn, but do not threaten. Never make a bluff or take one. Treat all alike, rich and poor.

Always do just as you say you will. Avoid even the faintest suspicion of dishonest or mercenary conduct. Let your conduct of the office commend itself to the fair-minded and level-headed people of the community, and don't worry about the others.

Make friends with the newspapers—they will help you more than anybody else. Give them news items about your work; they are glad to get news, and every item helps to educate public opinion on the rights of animals and children.

Be on good terms with other officials. Give them a chance to make their fees when they can. Advise with them. Defer to their opinion when you can. Get them all to help you when you can. Educating public sentiment on the rights of animals is one of the most important things you can do. Do it through the newspapers, the public schools, by speeches, and in any other way. Most of the value of a prosecution for cruelty is in its educational effect.

If your town is large enough, organize a branch society. Fix dues. Get a little money in the treasury to pay postage, attorney fees, and once in a while a man's time for a day when needed.

If you lose a prosecution, it doesn't matter; you won't have to prosecute that man again. The publicity, the expense and trouble hurt him worse than conviction would. If people oppose you, do not wonder or be discouraged; all reforms are opposed. It is sometimes slow, but "truth is mighty and will prevail."

Familiarize yourself with the statutes and your authority under them. Don't act on impulse. If you are sure you are right, don't be swerved by the opinion or representations of others. The responsibility is on you, not on them. And if they were in your place, they would, no doubt, change their views. Think about your work, and then think about it more.

If a case of cruelty is reported to you, don't make up your mind until you have investigated. If you find it serious enough to deserve a prosecution, get your evidence in good shape from two witnesses or more, if possible, on each material point. Be sure they are talking of what they know, have seen and heard themselves, and can swear to. Prosecutions are won on evidence generally. Be sure to get the best and strongest evidence obtainable.

If you find a case of apparent cruelty actually going on, stop it until you can investigate. First relieve the animal, and then punish the offender.

You have one extraordinary power, which you can use on the instant. You can take away from anybody, on your own judgment, any animal or animals, if you think they are abused. No other officer has such power. This enables you to deal with any case of cruelty on the spot.

In the case of abused children, agents have not the specific authority to take summary possession of them which they have in the case of abused animals, and would be justified in doing so only in extreme cases, when the child's life or limb is in jeopardy. To punish cruelty to children, follow the statute and, in a general way, the suggestions already given. County Courts, in their capacity to guard the interests of children, can issue orders concerning them of any kind necessary. County attorneys will give advice. Some individual, or the Bureau of Child and Animal Protection, may be made their guardian; or, which is generally best, where permanent guardianship is necessary, they may be sent to the State Home for Dependent and Neglected Children, under the law referred to in this book.

You will seldom need to make arrests yourself. Better file complaint, have warrants issued, and let the regular constable or deputy make arrests. It saves you time and sometimes trouble, and he makes his fees. But if it is necessary, in order to prevent escape beyond reach, to make an arrest, do not hesitate to do it. You can call on any peace officer to help you prevent cruelty, or a citizen also.

Take the name and address of anyone warned by you, and keep watch of him afterwards. When your warnings are unheeded, do not hesitate to prosecute. To begin prosecution, go to a justice of the peace, have a complaint made out, following the form of the statute, and swear to it. The court will then issue a warrant, and the constable will make the arrest. Follow the advice of the district attorney as to the trial of the case; if no district attorney is within reach, get some attorney to prosecute in his place. If there is no other way, you can prosecute the case yourself.

Cases of cruelty are misdemeanors, in legal phrase, and for the district attorney to prosecute. If the defendant is acquitted, the costs are paid by the county, as in other misdemeanor cases. It is the people of the State who prosecute, not the Bureau of Child and Animal Protection. The Bureau is interested in the prosecution, but is not a party to it.

Having authority, it is your duty to be active and conscientious in exercising it. Be on the lookout for cases of ill treatment of dumb animals and children. Shirk nothing. Sometimes it is an advantage to have a commission as a deputy sheriff. It is well to have it, if it be not too much trouble to get, because people yield to a familiar authority like that of the sheriff, when they are not disposed to yield to an unknown one.

Avoid giving the impression that you are anxious to profit in a mercenary way by your work. People will say you are working a "graft," and then your influence will be gone. As a matter of fact, agents should be paid for their services, just as other officers of the law are, and in time they will be.

There are countless other suggestions which might be made, but it should not be necessary. If you use good sense, carefulness, and firmness, you are not likely to make serious mistakes. Again, don't act on impulse or in haste. Consider each case coolly and impartially, and do what seems to be right.

Don't talk too much about your work. More bad feeling and ill-will are stirred up by idle and unnecessary talk than by what you may do. Don't bluster, threaten, and blow about what you are going to do or have done.

Lastly, be a "stayer." That is, be persistent; keep it up; don't get discouraged—if anybody else is, it is all the more reason you should not be. The only people who do any good are the "stayers." Be one.

The Colorado Humane Society and the State Bureau of Child and Animal Protection

For most practical purposes they are one and the same thing. The Colorado Humane Society is the corporate name of the original organization formed in 1881. It remained a Society, incorporated thus, till 1901—twenty years—raising what money it could and doing what good it could. In 1901, by act of the Legislature, it was made the State Bureau of Child and Animal Protection, still remaining the Colorado Humane Society, but in addition, becoming also a State bureau and a part of the regular State government. It is much the same as when a man is elected to a State office—he remains the same man, but in addition becomes a State official. As a man and citizen, he can do certain things, but as a State official he can do certain other and official things—he becomes a part of the State government and is paid by the State for his acts as such.

It is almost exactly the same with the Humane Society becoming by law a State bureau—it remains the Humane Society and can act as such, but in addition it becomes a State bureau and can be and is paid by the State in that capacity. It continues to elect its own officers just as it did before it became a State bureau—and thereby keeps its work free from political influences, which would shortly destroy its usefulness, as they have done in every other case of its kind.

Children and Dumb Animals

The question is sometimes asked, with implied criticism, why the protection of children and dumb animals is linked together. The answer lies in the essential helplessness of both and the fact that both can be protected for little more than the protection of either separately would cost. The same officers can enforce the law for both as they go along. Public sentiment demands the protection of both, regardless of any especial interest individuals may have or may lack in either over the other. Everybody wants children protected as a matter of course, and all intelligent and rightminded persons also want dumb animals protected.

The Legal Status of Dumb Animals

It is not generally realized that in law—as well as in fact—dumb animals are "persons." Almost nobody, in fact, does realize it. The rule of law is that the distinction between persons and things is that persons have legal rights, whereas things do not.

The law of this State and many others forbidding unnecessary injury to dumb animals defines a dumb animal as "any living dumb creature," forbids torturing, tormenting or cruelly treating any dumb animals, and further states:

"The words torture, torment and cruelty shall be held to include every act, omission or neglect whereby unnecessary or unjustifiable pain or suffering is caused, permitted or allowed to continue when there is a reasonable remedy or relief."

That would be a pretty comprehensive definition of human rights. If liberally and intelligently construed and applied, it would protect human rights better than the multiplicity of laws which now seek to do so.

In fact—as well as in law—everybody familiar with dumb animals knows that they are persons, each individual dumb animal having characteristics which make him different from any other individual of his kind—and that is what personality means. As far as they go they are exactly like us in all essential ways—they feel, think and reason just as we do, as far as they can. They are called dumb merely because they cannot pronounce and string words together, as we do. However unwilling some may be to admit this, it is, nevertheless, a scientific and established fact. When we say mankind and dumb animals, the emphasis should be laid on the word dumb, since man is himself an animal.

Reminiscences

The common law of England is the law of the United States except when it has been superseded or changed by statute in the various states, as is almost universally the case. Nevertheless our system of law is built upon the common law and its influence colors and saturates our American law. The common law was the general body of law made up of long-established rules and customs, of court decisions and other like materials during many hundreds of years in England, both before and after the Conquest in A. D. 1066—going back more than a thousand years ago.

Under the common law the so-called dumb animals had no rights but were merely property and could be abused, tortured and killed at the owner's whim. It is a curious proof of how close we still are to savagery, of how thoughtless and unintelligent we are, that it was not until 1811 only a little over a hundred years ago—that Lord Erskine, for the first time in the history of the world, sought to recognize in Parliament the moral rights of dumb animals by law. The unintelligent and brutal of that day, in Parliament and out, overwhelmed him with ridicule and abuse exactly as the same kind of people today behave toward the rights of dumb animals.

In 1824, however, Hon. Richard Martin, introduced a bill in Parliament establishing the rights of dumb animals by law—thereby automatically removing them from the class of property and things to the class of property and persons with individual rights. The same inferior class among his colleagues jeered and derided Martin as they did Lord Erskine—and as they do today whenever the rights of dumb animals are involved.

From that time on Societies for the Prevention of Cruelty to Dumb Animals began to spread in civilized countries, the first one in the United States being the American Society for the Prevention of Cruelty to Animals, organized in New York City in 1866 by Henry Bergh. Curiously enough to those who would segregate the protection of children from that of animals on account of the inferior position of dumb animals, the first society in the world for the prevention of cruelty to children came afterwards and grew directly out of the work of this first society in this country to protect animals. The first Society for the Prevention of Cruelty to Children in the world was organized in New York in 1875, by Elbridge T. Gerry, nine years after the S. P. C. A. was formed and based directly upon its work. There are now many hundreds of societies for the protection of children or dumb animals or both in the United States and in the civilized countries of the world.

The Colorado Humane Society, for the protection of both children and dumb animals, was formed in 1881, as previously stated, but did not become active until 1885, and in 1901 became, in addition, the State Bureau of Child and Animal Protection. Much of the general legislation for the protection of both children and dumb animals was passed through its efforts between 1885 and 1895. It comprises most of the fundamental law for the protection of both, later statutes being for the most part, special laws for special classes of cases.

It may give pleasure to its friends to recall very briefly some of its various experiences and achievements. Among them are:

The first law in this country, as far as we know, to compel able-bodied fathers to support their children.

The only law in the world to prevent insuring the lives of children—a practice everywhere condemned by organizations for the protection of children. This wise and salutary law remained in force for almost thirty years despite the determined and well-financed efforts of powerful interests to have it repealed, efforts which this organization alone opposed and which finally prevailed.

The only law specifically forbidding docking horses' tails—a hideously cruel and senseless practice which the automobile has since rendered practically obsolete.

Here, also, the practice of shooting live birds from traps was first stopped. It is now no longer permitted in any civilized country, excepting only the little principality of Monaco or Monte Carlo, where many things are openly done, not allowed elsewhere, which in fact appears to be the reason for the existence of the place. Many years after it was stopped here, the Hurlingham Gun Club of London, which makes the rules for trap shooting, forbade shooting of live birds from traps.

Coursing of captive rabbits with hounds was first stopped here. It now exists in only a few out-of-the-way places in one or two states and breeding of greyhounds for that purpose has practically ceased. All combats between captive animals and pursuit or killing of captive animals for "sport" is now forbidden by law here. Dog fighting and cock fighting, once so common, have been driven into such out of the way places and have been rendered so difficult and dangerous, they have practically ceased to exist here. Enforcement of the compulsory school law in Colorado was brought about through our efforts, in recognition of which fact the school board of Denver offered us the privilege of naming the first school attendance or truancy officer appointed in this state.

The State Home for Dependent and Neglected Children was established through the efforts of one of our volunteer officers, the late Elmer W. Merritt, State Senator at the time. Incidentally, it may be said that he was also the father of our Mountain Park system and of the City Park Museum—already world famous. Hardly any man has done more for his city and state or has received less credit.

Twenty years or so ago, stockmen complained to us that stock received at the Denver Union Stockyards had little shelter and for lack of paving, was compelled to lie and eat in deep mud and frozen slush, no attention being paid to owners' complaints by the stockyards management. We at once took a series of photographs of conditions and sent warning to the stockyards officials. Within 30 days, an additional 40 acres of land had been bought and contracts for \$100,000 worth of sheds, paving and other needed improvement had been let.

The most recent action with nation-wide results was our request to the Secretary of War within the year, to forbid taking dumb animals up in air planes or sending them down by parachute by any flyer in the army of the United States, a request which was at once granted. This action of ours was caused by the failure of a parachute to open to which a dog was attached, resulting, of course, in the dog's death.

The late Senator John F. Shafroth was always an active friend of our work. More than twenty years ago, when he was yet a congressman, at our request, he procured the incorporation of the following paragraph in all contracts made by the government for the transportation of mails on star routes, being moved to do so by the atrocities committed on horses and mules by stage drivers in the western and southern states. It was he, also, who introduced a bill for the creation of a federal board of child and animal protection in Congress at two successive sessions, neither of which, however, was favored by the committee having them in charge. He also induced the Bureau of Indian Affairs at Washington, to provide feed for the starving ponies of the southern Utes in southwestern Colorado and it was he who secured an increased appropriation for the Bureau of Child and Animal Protection when he was governor of this State. He was a good friend of this work and his advice and powerful influence were always at its command.

The friends of child and animal protection will be glad to know that Mrs. Bertie Berlin Kelly has provided in her will a bequest of \$5,000 for their benefit, to be administered by the Colorado Humane Society. She has long been a generous subscriber. Her mother, the late Mrs. Emma Berlin, was for many years an active and valued volunteer officer. The fountain at Broadway and Speer Boulevard was her gift to the City of Denver, for which she should have received credit in the list of the city's benefactors at the Civic Center.

In eastern states, a large part of the funds of societies for the protection of children and dumb animals comes from the interest on bequests like that of Mrs. Kelly. With one exception of \$500 bequeathed to the Society many years ago, hers is the first to be devoted to this cause in Denver.

There are many statutes in force here for the protection of children and dumb animals not in force in other states and countries, but for whose enactment we are but little responsible if at all. Some of them are of extreme importance and value if properly enforced. The law requiring school teachers to keep track of the physical condition of their children, reporting to the parents any abnormality found, would, if properly enforced, protect the health of every school child in the state and would do so in the only proper way, viz.: By act of the parents instead of that of hired nurses or physicians. There is no such law elsewhere. We have the best age of consent law, the only law against certain indecencies with children, the only law protecting women of good character regardless of age. We have the only law requiring the game and fish commissioner to provide food for starving game animals. All these statements were true at the time of the passage of these laws, and, as far as we know, are still true. The Bureau had little, if anything, to do with their passage, but it rests with us to secure their enforcement as far as possible.

It is doubtless true that nowhere else is there an equal area—almost twice the size of all New England—where children and dumb animals are protected to the degree and

extent they are in this State. If that is true, it is due first to the fact that the agency for protecting them is a part of the regular state government instead of being a Society, and secondly, to the system of volunteer officers, of whom there are something over 1500 scattered over the State. These men and women seek the authority the Bureau can givea great and largely discretionary authority-because they want children and dumb animals protected as far as possible and are willing to serve without pay in their behalf. That is, they are willing to give their time and service and very often some money, to risk incurring the displeasure of friends, neighbors and associates of all kinds to protect abused and neglected children and dumb animals in their respective localities without hope of compensation of any sort. All it costs the State is a little postage, printing and stationery and their badges of office. The amount of good they do is incalculable. The State owes them a debt of gratitude it does not even know of, to say nothing of appreciating it. The foremost place in Child and Animal protection which Colorado undoubtedly enjoys among communities of like area and population is due largely to their constant, devoted and brave efforts.

In general it may be said that during the twenty-five years of its existence as a State Bureau, it has never been obliged to retract a statement or retrace a step, nor has it ever been bullied, coaxed, fooled or bribed into doing what it considered wrong or into refraining from doing what seemed to be its duty. It is at least extremely doubtful if such a statement could be made if it were subject to political influences. In politics, other considerations are apt to be subordinated to the interests of politics. The personnel of boards, the employment of officers, the activities of employees, all are apt to be dictated by political considerations rather than the welfare of the beneficiaries of the board.

As the years have gone the work of the Bureau has changed in two outstanding ways. It is more and more used by town and county officials to handle cases more easily or better handled than they could be by such officials themselves. At this time probably half its work in the State comes from official sources—courts, county commissioners, superintendents of schools, marshals and sheriffs. The other change in its conduct lies in a gradual expansion in Humane education as distinguished from law enforcement. The Bureau has never had the means to carry out its plans in this respect, but has always been fully aware of the economy and efficiency involved in teaching children to be good instead of compelling them to be good after they have grown up.

At this time the Humane Educational Society, organized and directed by officers of the Bureau, and which will have the advice and aid of State Superintendent of Public Instruction, Mary C. C. Bradford, and Superintendent of Schools of the City and County of Denver, Alice Clark McCormick, gives promise of practical success throughout the schools of the State. Properly carried on, hardly any more important and beneficial work could be planned. The Bureau has no funds which can be applied to this purpose and the Humane Educational Society will have to raise the necessary money outside. We ask for the Society the active aid of our members and volunteer officers and of all good citizens.
