




Population

Population Estimates and Forecasts for the resident population are produced by the State Demography Office.

- Garfield County's population has growth steadily since the 1990s.
- From 1995 to 2010 the population in Garfield grew faster than the state.
- Since 2010, the growth in Garfield has flattened out to just over .5% per year.




Population By Age

Garfield County's population by age is shown in the chart to the right for both 2000 (darker bar) and 2010 (lighter bar). The largest increase in population occurred for residents over age 55. There was also significant growth in the youngest age groups as well, demonstrating an increase in families and family households over the decade. Prime working age adults (35 to 54 years old) also saw a large increase.



Population By Age, Continued

Garfield County is forecast to reach 64,000 by 2020 and 97,000 by 2040. The forecast growth rate is expected to return to an annual average growth rate of 2% per year from 2015 to 2030. Most of this growth is forecast for young adults, those most likely to move and their children under 10. The low growth in 30-39 year olds is the result of a much smaller cohort aging into 30-39 year old age group. The number of residents over age 70 will also increase, the result of current older residents aging in place. The forecast growth will be dependent on housing and community services and how well Garfield attracts and retains its population.



- The overall vacancy rate was 12.7% in 2010.
- The vacancy rate was slightly higher than the state average (10.8%), however, there is a vacant seasonal component to consider.
- A majority of units are owner occupied (65.9%) but an active rental market exists as well.

- There was an increase in households between 2000 and 2010.
- This increase can be seen across all household types, especially Family households including those with children under 18.
- This increase reflects the population growth in the 0 to 17 and 25 to 34 age groups.



- Garfield is more diverse than the state as a whole and is becoming more diverse over time.
- The Hispanic population increased by 119% between 2000 and 2010, while the White population increased by just 9%. Total population change was 29%.


Income

The graph below compares Garfield's income distribution to the state. Garfield has a slightly lower median household income than the state, \$57,214 vs. \$59,448. The largest share of households have incomes between \$75,000-99,999.



Education

- The largest share of the population has some college or an associate's degree, slightly higher than the state average.
- Garfield has a higher share of its population with less than a high school degree and with high school only compared to the state. The large share of foreign born population and tourism based jobs often leads to lower levels of education attainment.




Commuting

Commuting plays an important role in the economy of an area because not all workers live where they work. Commuting impacts local job growth, access to employees, and transportation infrastructure.

Close to 46% of the resident workforce (light green) works outside of Garfield County. Of the jobs in Garfield (dark green), 63% are filled by residents with 37% being filled by workforce from outside of the county. There are a large number of commuters between Pitkin and Eagle Counties as well as Mesa.

Garfield County Commuting Patterns, 2014



Jobs & the Economy

Total employment in the county was estimated to be 32,969 in 2014, down 3,700 jobs from Garfield's peak employment in 2008 of 37,706. Nearly all of the jobs lost during and after the recession were in construction, mining and retail trade. Since 2010 the industries that have seen the most growth in jobs have been accommodation and food services, health services, admin and waste, and transportation and warehousing. Industries above their pre-recession peak include government, health services, agriculture, and admin and waste.



Economic Industry Mix

The industrial mix in Garfield can be seen at left. The industry mix in the county is similar to the state, except for larger shares in construction and mining. The largest industries by employment are government, construction, retail trade, accommodation and food, and health services.

Garfield Base Industries, 2014





Economic Base Analysis

The Base Industries chart shows which industries drive the economy in Garfield. The chart shows the important share of economic activity driven by regional services (like construction and health care). Tourism, retirees, government and mining are also important economic drivers to the county. Retirees are a driver because they spend their savings or pensions locally. Transfer payments and commuters working in neighboring counties are smaller, yet important drivers.

Average Wage Trends

- Average weekly wages Garfield increased by 7% between 2010 and 2015 compared to the state which increased by 13%.
- Weekly wages of \$895 in Garfield in 2015 were 86% of the \$1,042 statewide average.
- Wages in Garfield were essentially unchanged in 2015, while statewide wages increased by 2.8%. Due to its concentration of mining and construction jobs, wages in Garfield are more volatile than statewide.



Population and Economic Forecast

The rates of growth of both population and jobs can differ somewhat because of changes in the labor market, i.e., labor force participation rates, age, unemployment rates, multiple job holding, and/or commuting. In addition, macroeconomic conditions such as business cycle fluctuations and faster or slower periods of U.S. and Colorado economic growth can affect overall job growth in a region.

- Population growth is forecast to roughly match job growth for the period from 2015 to 2020. After 2020, population growth is expected to significantly exceed job growth.
- Population growth after 2020 in Garfield County is in part driven by job growth within the surrounding region.
- This means that while employment isn't expected to be growing, population will. This may require additional housing and community services. Additionally, an aging population may require increased need for accessible housing and other aging services.
