1. INTRODUCTION

This study was completed on behalf of the CDOT Social Impact and Equity subcommittee, one of six committees participating in the CDOT Emerging Mobility Impact Study. The purpose of this study is to identify coverage and gaps in the service area of the statewide transportation providers covered under Senate Bill 19-239. These transportation providers are encompassed in six categories, including TNCs, taxis, peer car share, non-peer car share, car rental, and residential delivery. This gap analysis reveals whether disadvantaged populations in Colorado are adequately served by the transportation providers. The disadvantaged populations are defined as the census tracts within the Colorado counties that have high transit need and propensity as outlined in the Colorado Statewide Transit Plan¹. The analysis was completed using geospatial analysis and the results lead to conclusions about transportation providers' coverage among disadvantaged populations statewide.

2. METHODOLOGY

This study included two main steps, a statewide demographic analysis to determine transit propensity and a statewide transportation provider coverage analysis to determine service area.

A. Demographic Analysis




Figure 1a. Compilation of the Transit Need and Propensity Indicators by Census Tract

The demographic analysis was completed to determine the census tracts in Colorado with disadvantaged populations and transit need and propensity. US Census data was obtained for each census tract in Colorado for the following seven demographic characteristics: people with disabilities, people with limited English proficiency, minority populations, low-income populations, households without vehicles, veterans, and population over the age of 65. These factors were selected because they were used to determine transit propensity in the Colorado Statewide Transit Plan, 2015. This analysis was completed using GIS software and Figure 1a and Figure 1b display the results of this analysis.

The statewide rate for each characteristic was calculated and used as the baseline to determine if each census tract was above or below the statewide rate. The census tracts were sorted into two categories for each statistic, greater than statewide rate and less than statewide rate. The census tracts were assigned a point value of 1 for each characteristic greater than the statewide rate. The census tracts were then ranked on the following scale:

- 5-7 Characteristics Above Statewide Rate = Highest Transit Needs
- 2-4 Characteristics Above Statewide Rate = Higher Transit Needs
- 0-1 Characteristics Above Statewide Rate = Moderate Transit Need




Figure 1b. Compilation of the Transit Need and Propensity Indicators by Census Tract

B. Transportation Provider Coverage Analysis

The service area of the six categories of transportation providers was determined by researching maps or lists of municipalities included in the service areas on providers' websites, see Appendix A for the source of information. The six transportation providers and examples of the companies are as follows: (Note that additional analysis to include transit service providers will be provided in subsequent drafts of this memo.)

Some transportation providers listed municipalities included in their service areas while others provided a map on their website. These service areas were coded in GIS, either using the boundary shown on the providers' website with a two-mile buffer or municipal boundaries when a service area map was not available. It should be noted that these service areas are widely varied and unpredictable.² A geospatial analysis was completed using GIS software to determine which census tracts in Colorado are served by the transportation providers. Note that some datasets may be incomplete; the data represented herein is the most current available data.

3. RESULTS




Figure 2a.Compiled Transportation Provider Locations overlaid on Transit Need

The analysis revealed that the majority of Colorado census tracts are covered by one or more transportation providers, but coverage is lower for higher transit need and propensity tracts and lowest for the highest transit need and propensity tracts. Service providers that partially covered a census tract were included in the number of transportation providers per census tract, as displayed in Figure 2a and Figure 2b. The results from the geospatial analysis are as follows:

- 10.42% of highest propensity tracts have zero transportation providers (5/48)
- 6.3% of higher propensity tracts have zero transportation providers (67/807)
- 1.02% of moderate propensity tracts have zero transportation providers (4/394)





Figure 2b. Compiled Transportation Provider Locations overlaid on Transit Need






Figure 3b. Car Rental Providers overlaid on Transit Need

The service area coverage varied by transportation provider type. Figure 3 through Figure 8 display the service area coverage by transportation provider type overlaid on census tracts displayed by transit need. Figure 9 through Figure 14 display the service area coverage by transportation provider type overlaid on Transportation Planning Regions (TPR) and Metropolitan Planning Organization (MPO) boundaries.

While the overall service area coverage rate is high, there are some gaps in the service areas. The bulk of the transportation providers' service areas are located along the I-25 corridor, with the highest density seen from Fort Collins/Denver to Colorado Springs. Most notably, these gaps can be seen in the eastern plains and in the northwest quadrant of the state. Transportation providers become increasingly sparse the further from major highways. Areas to the east of I-25 - especially to the east of Peyton, Falcon, Brush and La Junta - have very few transportation provider service areas (approximately five total).

Several outliers were identified that did not follow this pattern of higher concentration of service area coverage in urban as compared to rural areas. The residential delivery services were found in many rural areas throughout the state. There is also a higher concentration of transportation providers, including transportation network companies, in rural areas that can be characterized by tourist attractions or ski resorts. Car rental service areas are concentrated around airports across the state. Peer car share spans more rural census tracts than non-peer car share.





Figure 4a. Non-Peer Car Share Providers overlaid on Transit Need







Figure 4b. Non-Peer Car Share Providers overlaid on Transit Need





Figure 5b. Peer Car Share Providers overlaid on Transit Need









Figure 6b. Residential Delivery Providers overlaid on Transit Need











Figure 8a. Transportation Network Companies overlaid on Transit Need







Figure 8b. Transportation Network Companies overlaid on Transit Need

Figure 9. Car Rental Providers overlaid on TPR/MPO Boundaries






Figure 10. Non-Peer Car Share Providers overlaid on TPR/MPO Boundaries

Figure 11. Peer Car Share Providers overlaid on TPR/MPO Boundaries




Figure 12. Residential Delivery Providers overlaid on TPR/MPO Boundaries







Figure 13. Taxi Service Providers overlaid on TPR/MPO Boundaries






Figure 14. Transportation Network Companies overlaid on TPR/MPO Boundaries

4. CONCLUSION

The service areas for the six transportation providers analyzed were not distributed equitably across the state. Disadvantaged communities with higher populations of people with disabilities, people with limited English proficiency, minority populations, low-income populations, households without vehicles, and people over the age of 65 have less access to transportation providers. In addition, rural areas have less access to transportation providers than urban areas. The majority of transportation providers that do provide access in rural areas may be catering to tourists, rather than residents in those areas. This study provides the CDOT Social Impact and Equity subcommittee data and conclusions about coverage and gaps in the service area of the transportation providers covered under CDOT Senate Bill 19-239.

Given the assumptions made in this analysis, it is recommended that the State of Colorado gather additional data sets on number of providers and location of service areas from the different emerging mobility providers. This data could be compared before and after a potential fee structure is implemented to assess the impacts on the vulnerable populations in the State of Colorado.
